Eligibility for scheme application:

Validation into this scheme is at a cost of £15 per application, this is a single payment which allows you and your nominees to become an Associate Partner of the scheme. The people that you are able to include in your list of nominees include your Spouse or partner*; parents and stepparents; brothers and sisters; stepbrothers and stepsisters; children and stepchildren, **not** in-laws. Nominations made at the time of member registration are included in the initial fee.

Registration requests for individuals requesting nomination/being nominated at a later date are subject to a further £15 fee.

The Validated Applicant and their nominated relatives can purchase a total of six vehicles, consisting of Vauxhall, Saab and/or Chevrolet vehicles, within any 12-month period. Vehicles purchased on the Vauxhall Partners Programme must be kept for a minimum of 11 months.

*** Common-law spouses or same sex partners; are also eligible. To satisfy the company that a genuine partnership is involved a copy of either a utility bill or credit card statement, bearing the same address as the validated applicant, is required. This copy will be held in the vehicle registration file for audit purposes. Only one partner can be registered per employee.**
